- I declare that I have read the content of the Information clause.

At any time, I have the right to withdraw consent to the processing of personal data, by sending a message to the e-mail address [circularpp@rarr.rzeszow.pl](mailto:circularpp@rarr.rzeszow.pl). Withdrawal of consent does not affect the legality of the processing which was carried out before its withdrawal.

### **Information clause**

By fulfilling the information obligation resulting from art. 13, paragraph 1 and paragraph 2 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/ EC (general regulation on data protection) (OJ.U.E.L.2016.119.1), hereinafter referred to as GDP - in connection with the collection of personal data from you, we inform you that:

Your personal data are processed on the basis of art. 6 par. 1 lit. a) GDP, your consent, in order to subscribe and send the newsletter within the project entitled: *“Using innovation procurement and capacity building to promote circular economy”* (project acronym: Circular PP, no. R049) and / or to send information on future events and actions taking within the project sending with using telecommunications terminal equipment, i.e. to the provided e-mail address, and on the basis of art. 6 par. 1 lit. f) GDP - in order to investigate / protect possible claims.
4. You may withdraw your consent to the processing of personal data at any time by sending information to the following e-mail address: [circularpp@rarr.rzeszow.pl](mailto:circularpp@rarr.rzeszow.pl). The exercise of the right to withdraw consent does not affect their processing until the withdrawal of consent.

5. Bearing in mind the above, you have the right to:
  - to obtain information whether your data is processed by us, and if so also the right to access it,
  - the right to rectify personal data if the data is incorrect,
  - the right to supplement incomplete personal data,
  - the right to its removal,
  - the right to limit the processing of personal data,
  - lodging a complaint to the President of the Office for the Protection of Personal Data.

Your personal data will be stored until you withdraw your consent, but no longer than until the end of the project and its durability – *“Using innovation procurement and capacity building to promote circular economy”* (project acronym: Circular PP, no. R049), where the Rzeszow Regional Development Agency S.A. is a partner.
7. Providing data is voluntary, but failure to do so will prevent receiving newsletters within the project entitled: *“Using innovation procurement and capacity building to promote circular economy”* (project acronym: Circular PP, no. R049) and / or e-mails regarding future events and actions carried out as part of the project.
8. Your personal data will not be subject to automated decision making, including profiling.
9. The data controller does not transfer data outside the territory of the Polish / EU / European Economic Area, subject to the transnational nature of data flow under the Mailchimp service in accordance with the EU-U.S. Privacy Shield Framework and the Swiss-U.S. Privacy Shield Framework rules, which were approved by the European Commission by Decision C (2016) 4176 of 12 July 2016.
